

Instructions for sample submission to MatMaCorp

Please read all instructions before collecting samples and filling the order form.

I. Order Form:

1. Please complete all relevant sections and email to testing@matmacorp.com.
2. It is necessary for the submitter of the samples to **sign the completed form**.
3. Payment in the form of a check or a completed credit card information has to be included with the samples.
4. Samples will not be processed without payment. We do not bill or send invoices for this type of service.

** If large number of samples are being submitted, you can use an Excel spreadsheet with the Sample ID and Sample Type information and send it to testing@matmacorp.com along with the corresponding documents.

II. Sample Types:

1. MatMaCorp will accept blood in EDTA tubes (purple top tubes), blood cards (GeneSeek/Neogen/Whatman FTA), semen straws (frozen or on ice), semen in tubes (frozen or on ice), tissue sample including ear notches (frozen, on ice, or in brine) and the Allflex TSU (tissue sampling unit). **The Allflex TSU is the preferred sample type.**

III. Shipping Samples to MatMaCorp:

1. Before shipping samples, please email a completed sample submission form to testing@matmacorp.com. This will alert our testing department to look for your samples.
2. Blood cards and Allflex TSU samples can be shipped at room temperature. Please pack samples with adequate protective materials (Styrofoam peanuts, bubble wrap etc.) to ensure they arrive intact.
3. Blood in EDTA tubes (purple top) can be shipped on wet ice. It is recommended that you put blood tubes in a plastic sealable pouch before packing them. Do not freeze blood tubes.
4. All other sample types can be shipped frozen or on wet ice. Please make sure there is a sufficient amount of wet/dry ice to prevent spoilage.
5. **A copy of the completed and signed form along with payment should be included with the samples.** If samples are shipped on wet/dry ice, please put all paper forms etc. in a plastic sealable pouch (Ziplock or similar).

- Acknowledgment and Acceptance.** Please read the following terms of the agreement carefully. By completing the order form, CLIENT hereby agrees to all of the terms and conditions set forth in the order form, including all warranty disclaimers and limitations of liability. ACCEPTANCE OF SERVICES SHALL BE DEEMED AGREEMENT TO THESE TERMS AND CONDITIONS. NO DOCUMENT ISSUED BY CLIENT ATTEMPTING TO NEGATE OR OTHERWISE MODIFY THE TERMS HEREOF, INCLUDING ANY PURCHASE ORDER OR REQUEST FOR PROPOSAL, SHALL BE BINDING UPON MATMACORP, AND INSTEAD THE FOREGOING TERMS AND CONDITIONS SHALL EXCLUSIVELY GOVERN THE PROVISION OF SERVICES TO CLIENT BY MATMACORP.

If, after delivery and inspection, CLIENT determines that the services do not conform to the test CLIENT selected and are, therefore, unacceptable, please notify us immediately. MATMACORP will either re-perform the services, or issue a credit therefore, at our option.
- Warranty or Representation Disclaimers.** MATMACORP DISCLAIMS AND EXCLUDES ALL WARRANTIES OR REPRESENTATION OF ANY KIND, EITHER EXPRESS, IMPLIED OR STATUTORY, WITH RESPECT TO ITS SERVICES, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT OF A PATENT, TRADEMARK OR OTHER INTELLECTUAL PROPERTY RIGHTS, OR WARRANTIES ARISING BY COURSE OF DEALINGS OR CUSTOM OF TRADE. - Limitation of Liability.** EXCEPT AS AFOREMENTIONED, MATMACORP WILL NOT BE LIABLE FOR ANY CAUSES OF ACTION OR DAMAGES WHETHER BASED ON CONTRACT, TORT, OR ANY OTHER LEGAL THEORY, INCLUDING ANY INDIRECT, CONSEQUENTIAL (INCLUDING LOST PROFITS AND LOST BUSINESS OPPORTUNITIES), SPECIAL, EXEMPLARY, OR PUNITIVE DAMAGES, ARISING OUT OF THE PERFORMANCE OF SERVICES EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. CLIENT is responsible for taking all precautions CLIENT believes necessary or advisable to protect any sample sent to MATMACORP against damage, loss or hazard.
- Indemnity.**
 - MATMACORP Indemnification. MATMACORP shall indemnify, defend and hold harmless CLIENT and its members, shareholders, agents, directors, officers, and employees (collectively, the "CLIENT Indemnities") from and against all liability, damage, loss, claims, demands, actions and expenses of any nature whatsoever including, but not limited to, reasonable attorney's fees and expenses, which arise out of or are connected with (i) any grossly negligent act or omission, willful misconduct or violation of law by MATMACORP, or its employees which relates in any manner to the Services or (ii) any material breach of any obligations of MATMACORP as set forth in these Terms and Conditions.

- Entire Agreement.** These terms and conditions form an appendix to any primary agreement (AGREEMENT) between MATMACORP and CLIENT applicable to MATMACORP's services. These terms and conditions may not be amended or supplemented by CLIENT without MATMACORP's prior written consent.
- Severability.** If any of the provisions of these terms and conditions shall be held by a court of competent jurisdiction to be contrary to law, the remaining provisions for this Agreement shall remain in full force and effect to the fullest extent of the law.
- Successors and Assigns.** These terms and conditions shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, legatees, devisees, personal representatives, successors and assigns.
- Survival.** The provisions of Sections 5 and 6 of these terms and conditions shall survive the completion and payment of the services provided hereunder.
